



Invitation to Bid

The **MUNICIPAL GOVERNMENT OF SAN VICENTE, PALAWAN**, through the 20% Development Fund for CY 2014 *intends* to apply the sum of **EIGHT HUNDRED FIFTY NINE THOUSAND NINE HUNDRED SIXTY PESOS (Php 859,960.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **SUPPLY AND DELIVERY OF MATERIALS FOR THE CONSTRUCTION OF REINFORCED CONCRETE SEA PROTECTION WALL IN BGY. POBLACION, THIS MUNICIPALITY/2015-003**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The **MUNICIPAL GOVERNMENT OF SAN VICENTE, PALAWAN** *through its Bids and Awards Committee* now invites bids for the **SUPPLY AND DELIVERY OF MATERIALS FOR THE CONSTRUCTION OF REINFORCED CONCRETE SEA PROTECTION WALL IN BGY. POBLACION, THIS MUNICIPALITY**. Supply of the goods is required within thirty (30) working days upon received of Purchase Order. Bidders should have completed, within the last two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section I8. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
 - (i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. The **BAC of the Municipal Government of San Vicente, Palawan** will hold a Pre-Bid Conference on **February 10, 2015 2:00 p.m** , at **Municipal**

Conference Room, San Vicente, Palawan which shall be open only to all interested parties who have purchased the Bidding Documents.

5. Interested bidders may obtain further information from the **BAC of the Municipal Government of San Vicente, Palawan** through its Secretary and inspect the Bidding Documents at the address given below during **8:00 a.m to 5:00, Monday – Friday**.
6. A complete set of Bidding Documents may be purchased by interested Bidders on **February 3 to 23, 2015** from the BAC Secretariat Office and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **Php 1,000.00**.
7. Bids must be submitted on **February 23, 2015 2:00 p.m @ Municipal Conference Room, San Vicente, Palawan**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on **February 23, 2015 2:15 p.m @ Municipal Conference Room, San Vicente, Palawan**. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the above-mentioned address. Late bids shall not be accepted.

8. **The Municipal Government of San Vicente, Palawan** reserves the right to reject any or all bids, waive defect of formality thereof, assumes no obligations whatsoever to compensate or indemnify bidder(s) for any expenses incurred in the preparation of their bids; and if the source of funds for the project has been withheld or reduced through no fault of the procuring entity.
