The **MUNICIPAL GOVERNMENT OF SAN VICENTE, PALAWAN** *through its Bids and Awards Committee* now invites bids for the **SUPPLY AND DELIVERY OF HARDWARE MATERIALS FOR THE CONSTRUCTION OF DAY CARE CENTER AT PANAMIN, BARANGAY CARURAY, SAN VICENTE, PALAWAN**. Supply of the Goods is required within thirty (30) working days upon received of Purchase Order. Bidders should have completed, within the last two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section 18. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
 - (i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. The **BAC of the Municipal Government of San Vicente, Palawan** will hold a Pre-Bid Conference on **March 24, 2015, 9:00a.m,** at **Municipal Conference Room, San Vicente, Palawan** which shall be open only to all interested parties who have purchased the Bidding Documents.
5. Interested bidders may obtain further information from the **BAC of the Municipal Government of San Vicente, Palawan** through its Secretary and inspect the Bidding Documents at the address given below during **8:00 a.m to 5:00, Monday – Friday**.
6. A complete set of Bidding Documents may be purchased by interested Bidders on **March 17 to April 6, 2015** from the BAC Secretariat Office and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **Php 500.00**.
7. Bids must be submitted on **April 6, 2015 2:00 p.m @ Municipal Conference Room, San Vicente, Palawan**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on **April 6, 2015, 2:15 p.m @ Municipal Conference Room, San Vicente, Palawan**. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the above-mentioned address. Late bids shall not be accepted.
8. **The Municipal Government of San Vicente, Palawan** reserves the right to reject any or all bids, waive defect of formality thereof, assumes no obligations whatsoever to compensate or indemnify bidder(s) for any expenses incurred in the preparation of their bids; and if the source of funds for the project has been withheld or reduced through no fault of the procuring entity.
